# Wacky Boat Race

Prizes will be awarded on the basis of innovative design, as well as speed. The rules prohibit raiding another's crew, boarding a competing vessel or kidnapping rival crew members. Battering with water balloons is permitted. Competitors are expected to employ as much ferocity and unscrupulousness as may escape the judges' notice.

If you are confident in your boat-building abilities, you can make your boat into a floating piece of artwork. Once you have a stable base shape, create a concept that will take the boat to the next level. You might design the craft as a pirate ship, complete with cardboard masts and sails, or you might use paint to create a floating tribute to a favorite artist. For a fun twist, make your boat into something that wouldn't normally float, like a car, tank, train or airplane. As long as the base of the boat is steady, you can add on modifications and still float safely.

The homemade boat must be "people powered" - no motors. See **THE RULES** for complete instructions.

Be sure to arrive early to allow time to check-in and line up for the People's Choice Judging.
